



## **MEMORANDUM OF UNDERSTANDING**

**BETWEEN**

**Sant Longowal Institute of Engineering and Technology, Longowal**

**AND**

**Harcourt Butler Technical University, Kanpur**

### **Principal Agreement**

This Memorandum of Agreement between the Sant Longowal Institute of Engineering & Technology (SLIET), Longowal and Harcourt Butler Technical University (HBTU), Kanpur is intended to facilitate a collaborative program of research, skill development, consultancy, institutional development, information dissemination and students in-plant training. The linkage hereby formed shall further strengthen each partner institution's objectives as well as the mutual relationship between the partners.

**Now it is hereby agreed as follows:**

### ***Article 1. Scope of cooperation***

The scope of MoU covers educational and academic exchanges here to but not limited to:

1. Joint consultancy for Industries.
2. Student Research Projects/ In-plant trainings
3. Coordination of joint research projects and lectures.
4. New product development and incubation services with research institutes and industries.
5. Exchange of documentation and research materials in fields of mutual interest provided that, to the best knowledge of the respective institutions, there is no prohibition at law or otherwise against the exchange.

### ***Article 2. Mechanism of Implementation***

For the purpose of implementation of this MoU SLIET, Longowal, will be represented by Prof. <sup>Dr.</sup> ~~AS Dhaliwal~~ Dean (R&C), and Prof. Kamlesh Prasad, HOD (Food Engineering and Technology) and HBTU will be represented by Dr. Alak Kumar Singh, HOD (Food Technology).

These representatives may meet as and when necessary to draw plans of action and to review the progress in the implementation of the agreed arrangements as outlined in Article 1.

If necessary, separate subsidiary agreements may be signed for one or more of the activities mentioned in Article 1 for specific details and terms and conditions. All activities under this MoU shall be subject to availability of resources and approval by the competent authorities of the respective organizations.

Details of the implementation of any particular student or faculty-related activity resulting from this Memorandum of Understanding shall be negotiated between the institutions as such specific case may arise and will be outlined in a Supplementary Student Research Agreement or Faculty Research Agreement between the institutions.

### ***Article 3. Financial obligations***

For each activity outlined in Article-1, the extent of financial commitment by the two organizations will be separately negotiated and agreed upon. Supplementary Agreements are subject always to availability of sufficient funds to the respective institutions. Prior to final agreement and the carrying out of any activity arising from this MOU both SLIET, Longowal and HBTU, Kanpur must obtain the concurrence in writing of their respective finance / Accounts and Audit Sections.

### ***Article 4. Duration of MoU***

This MoU will come into force on the date of its execution by the authorized signatories from both the institutions. It shall continue in effect for a period of **five years** and may be extended by mutual agreement.

It may be terminated by either institution upon three months written notification to the partner institution. The termination of this MOU shall not affect the implementation of the activities already established under it prior to such termination.

### ***Article 5. Amendments***

This Memorandum of Understanding reflects the respective institutions' commitments to both educational and research exchanges as of the date of the Memorandum of Understanding. This Memorandum of Understanding may be amended or terminated at any time by either party provided that notice of termination or amendment is provided by the notifying party to the other party within thirty (30) days of the date on which the termination or the amendment is intended to become effective. Any amendment or termination shall not have effect on any arrangement in place at the time that the notice is provided, where the arrangement arises from any Supplementary Agreements resulting from this Memorandum of Understanding.



### **Article 6. Intellectual Property**

Any intellectual property arising out of the implementation of this MoU shall be secured and maintained by mutual consent according to the provisions of the IPR Rules of SLIET, Longowal, and HBTU, Kanpur.

### **Article 7. Settlement of disputes**

Any dispute, conflict of interest or problems arising out from the application or interpretation of this MoU shall be resolved by mutual discussion and in good faith by designated /nominated representatives of both the organizations as mentioned in Article-2.

### **Article 8. Legal status**

Both institutions subscribe to the policy of equal opportunity and will not discriminate based on gender, age, disability, race, color, religion, marital status, veteran's status, national or ethnic origin, or sexual orientation. Nothing in this MoU shall be construed as creating any legal relationship between the parties. This MoU is a statement of intent to foster genuine and mutually beneficial cooperation.





MEMORANDUM OF UNDERSTANDING

Longowal-148106 (Punjab) (CFTI established by Govt. of India)



1. **Central University of Punjab, Bathinda** hereinafter referred to as "CUPB" has been established through the Central Universities Act 2009 approved by the Parliament of India. This fast-growing Central University is set to emerge as a premier educational institution with the state-of-the-art infrastructure to provide quality education and research.
2. **Sant Longowal Institute of Engineering and Technology (SLIET), Longowal** was established by Ministry of Human Resource and Development (MHRD), Government of India in the year 1989. It is an autonomous body, fully funded by Government of India and controlled by SLIET society, registered under Societies Registration Act, 1860. It has vision to act as an international podium for the development and transfer of technical competence in academics. It is committed to provide best possible technical education and to cater to the technical manpower requirements with emphasis on practical training in industry.

This MEMORANDUM OF UNDERSTANDING (MoU) is entered into on this day of  
12.01.2021

BETWEEN

Department of Applied Agriculture, Central University of Punjab, Bathinda being represented by its Prof. Anjana Munshi, HOD having its office at Bathinda, Punjab in India, herein after referred to as the FIRST PARTY.

AND

Department of Food Engineering & Technology, Sant Longowal Institute of Engineering and Technology, Longowal being represented by its Prof. P.S. Panesar, Professor having its office at Longowal, (Punjab) hereinafter referred to as the SECOND PARTY.

WHEREAS, the FIRST PARTY is Department of Applied Agriculture of national importance engaged in advancement of teaching and research in several branches of sciences including food science and technology.

WHEREAS, the SECOND PARTY is Department of Food Engineering & Technology which is also an institute of engineering and technology which engaged in teaching and research and development in the field of food science & technology.

WHEREAS both the parties have come to an understanding to promote cooperation between the two organizations in the field of food science & technology. The main objective of the MoU is to enhance the academic and research exchange between the two participating institutes.

THEREFORE, IT IS HEREBY MUTUALLY AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. Both the parties will promote and intensify collaboration in research (usage of lab techniques and equipments), academics, training activities of food science and

- technology, food engineering, food biotechnology and related areas of bilateral interest.
2. Whereas in pursuance and furtherance of the objectives of (i) the promotion of knowledge of food science in India and its practical application to problems of national welfare, (ii) to secure coordination between food science and Institute of basic research, and (iii) to seek help and cooperation of national/international bodies to further the progress of food sciences.
  3. Both the parties will work together to promote and enhance the academic interchange between the two institutions.
  4. Both the parties will encourage and facilitate the visit of students and faculty in their respective institutes.
  5. The students of both the collaborating Institutes may seek guidance/mentorship/supervision from the concerned faculty working in their area of research.
  6. Both the collaborating Institutes will co-operate to:
    - i. Identify the projects of mutual interest.
    - ii. Identify the research proposals between the partner including exploring possibilities for grants and other forms of funding.
  7. Research student guidance as Supervisor/Co-supervisor in both the institution mutually (It depends upon registration of student in the university, if it is in CUPB then supervised otherwise Co-supervisor).
  8. Any intellectual property arising out of the implementation of this MoU shall be secured and maintained by mutual consent according to the provisions of the IPR rules of SLIET, Longowal, and CUPB as per mutually agreed terms and conditions.
  9. This MoU is intended to facilitate discussions on the joint educational and cultural activities. This MoU shall be valid for a **period of five** years. Either Department of Food Engineering & Technology, SLIET, Longowal, or Department of Applied Agriculture, CUPB, India may terminate the MOU by giving 02 months' notice in writing to the other party. The termination of this MOU shall not affect the implementation of the activities already established under it prior to such termination.
  10. For each activity, the extent of financial commitment by the two organizations will be separately negotiated and agreed upon. Prior to final agreement and the carrying out of any activity arising from this MOU both SLIET, Longowal, and CUP, Bathinda must obtain the concurrence in writing of their respective finance / Accounts and Audit Sections.

## **TERMS AND CONDITIONS**

1. It is a joint research collaboration only and not meant for awarding any joint degree or diploma.
2. The MoU shall deemed to have been automatically rescinded after the expiry of the MoU period, unless renewed for any further period as per mutually agreed upon terms at a later stage.



3. Either of the parties hitherto shall be entitled to terminate the MoU at any time with valid reasons, acceptable in writing to both parties and in such case, the MoU will terminate on the date of written notification or date of expiry of the MoU, whichever is earlier. In case of such premature termination of the MoU, all rights and obligations of both parties shall automatically cease except for those covered by written contracts, including ongoing collaborative activity that can no longer be cancelled.
4. Termination of MoU shall be done in a cost-effective manner subject to proper turnover and accounting of expenses that may have been incurred, where applicable.
5. Even after termination of MoU the students working on the joint project proposal for a degree will continue their research work until the completion of degree.
6. In case of any dispute that may crop up during execution of MoU, the matter would be settled through arbitration by referring to a committee jointly appointed by both the parties. Nothing in this MoU shall be construed as creating any legal relationship between the parties. This MoU is a statement of intent to foster genuine and mutually beneficial cooperation.
7. Neither party shall be responsible for non-fulfillment of their respective obligations under this agreement due to the exigency of one or more of the force majeure events such as but not limited to acts of God, War, Flood, Earthquakes, Strikes not confined to the premises of the party, Lockouts beyond control of the party claiming force majeure. Epidemics, Riots, Civil Commotions, etc. provided on the occurrence and cessation of any such event the party affected thereby shall give a notice in writing to the other party within one month of such occurrence or cession. If the force majeure conditions continue beyond six months, the party shall jointly decide about the future course of action.

There shall be no financial burden either on the Institute or the students, as Sabudh Foundation have agreed to provide the training free of cost to the students as mandated in the MoU signed.



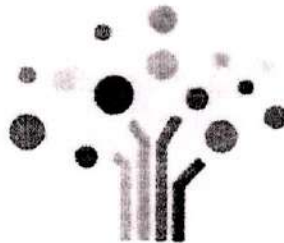

# MEMORANDUM OF UNDERSTANDING BETWEEN

SABUDH FOUNDATION, SAHIBZADA AJIT SINGH NAGAR


Whereas, **Sabudh Foundation**, (hereinafter referred to as "SF", which expression shall unless repugnant to the context thereof, include its successors and permitted assigns), a not for profit section 8 company, registered at #329, sector 33A, Chandigarh and having its office at D-228, Third Floor, Sector 74, Sahibzada Ajit Singh Nagar, Punjab 140307 and hereinafter unless the context otherwise requires be referred to as **Sabudh Foundation**

Whereas, **SANT LONGOWAL INSTITUTE OF ENGINEERING & TECHNOLOGY (SLIET), LONGOWAL, PUNJAB** has been established and funded by Ministry of Education, Government of India in 1991 to provide technical education in emerging areas of Engineering and Technology. This Institute has a beautiful sprawling green area of 451 acres, with many topographically featured picturesque landscape and presents a spectacle of harmony and natural beauty. The Institute offers programs such as certificate diploma, undergraduate (B.E.) & postgraduate (M.Tech.) degree and Ph.D. levels in various branches of Engineering and Science. It caters to the technical human resources requirements at various levels in Industries/Institutions by imparting professional education with an emphasis on industrial training and entrepreneurship development.

WHEREAS, both SLIET, Longowal and Sabudh Foundation, now

- Recognizing the need to create momentum in Artificial Intelligence, Machine Learning and other advanced technologies in the Punjab Region
- Appreciating the value that these technologies can bring to society
- Desiring to establish a Centre of Excellence (Data Hives) and create solutions using these technologies to impact society
- Recognising that if local talent is not developed, the region will be dependent on foreign innovation that may or may not be optimal for the peculiarities of our society.

Intend to collaborate in the establishment of the Sabudh Data Science for Social Good Center in Mohali that will train students in these advanced technologies and create a momentum in research, both applied and fundamental, that has the potential of addressing social problems in the region.



NOW, THEREFORE, in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both Department of EIE, SLIET, Longowal and Sabudh Foundation hereby acknowledge and agree to sign a Memorandum of Understanding (MOU).

### **ARTICLE-I: SCOPE OF THE MOU**

The Sabudh Data Science for Social Good Centre will be established in collaboration with leading academic institutions with the intention of

- Bringing the best academic and industry content for educating local talent in advanced technologies
- Establishing a Centre of Excellence (Data Hives) at SLIET, Longowal through EIE department.
- Conduct workshops and training courses for students and academics
- Idiate projects of Social Impact with Government agencies and Society.
- Execute on projects with social impact with students, academics and industry mentors.
- Raise awareness of the impact these technologies will have on society
- Develop apps for data collection, where required, to allow for the development of social impact solutions.
- Support social entrepreneurship amongst students
- Develop local IP and provide support for it being exploited by developing IP sharing agreements between related parties

### **ARTICLE-II: SCOPE AND TERMS OF INTERACTIONS**

#### **SABUDH FOUNDATION:**

- Provide Industry ready training in advanced technologies such as Machine Learning, AI, Cyber Security, IoE
- Bring social problems for researchers to engage with
- Bring our extensive network of world wide academics and industry leaders and industry leaders to interact with SLIET academics and students
- Train students in advances in Machine Learning, AI and other future technologies
- Work with SLIET, Longowal to bring funding for social projects
- Raise awareness of the great work on the subject happening in the Punjab region






- Organise dissemination workshops
- Provide access to top companies in this space for student employment
- Attract industry to engage/invest with research in the institute
- Attract investment in the Punjab region in advanced technologies
- Provide Master/Phd thesis opportunities to students
- Run faculty development programmes
- Run awareness workshops in departments of the SLIET, Longowal on how these advanced technologies can help advance their own subject areas
- Co-teach modules on advanced technology areas
- Create data repositories associated with local Punjab context

### **SLIET, LONGOWAL**

- Filter good students for the two/six month internship at the Sabudh Foundation
- Faculty to engage in research on social good projects with the Sabudh Foundation on topics of interest
- Provide mentorship to students at the Foundation on projects of interest
- Produce e-content for training students in topics of expertise
- Provide a single point of contact that will actively participate in regular Steering Committee meetings
- The monitoring and liaisoning with SPOC of Sabudh foundation would be through Training & Placement Department of SLIET.

### **ARTICLE-III: EFFECTIVE DATE AND DURATION OF MOU**

- This MOU shall be effective from the date of its approval by competent authorities at both ends.
- The duration of the MOU shall be for a period of 5 years from the effective date.
- During its tenancy, the MOU may be extended or terminated by a prior notice of not less than 3 months by either party. However, termination of the MOU will not in any manner affect the ongoing projects or trainings being undertaken at that point of time under the MOU.
- Any clause or article of the MOU may be modified or amended by mutual agreement of Sabudh Foundation and SLIET, Longowal.



#### ARTICLE-IV: IPR


- Rights regarding publications, patents, royalty, ownership of product, design, process, code-base etc under the scope of this MOU, shall be decided by the two parties by mutual consent.

#### ARTICLE-V: CONFIDENTIALITY

- During the tenure of the MOU both SLIET, LONGOWAL and SABUDH FOUNDATION will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance this MOU.
- Both SLIET, LONGOWAL and SABUDH FOUNDATION shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement or PROJECTS.
- Further both SLIET, LONGOWAL and SABUDH FOUNDATION shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.
- CONFIDENTIAL INFORMATION shall mean any proprietary information, data or facts belonging to PARTIES collectively or severally, disclosed by the disclosing party under this agreement or any subsequent agreement, whether in writing, verbal or electronically, irrespective of the medium in which such information is stored, which is marked confidential or with any other words having similar meaning by the disclosing party, or specifically agreed to be kept confidential by the parties, or declared or identified so by the disclosing party before such disclosure or during the discussions.

However confidential information shall not include any data or information which:

- Is or become publicly available through no fault of the receiving party
- Is already in the rightful possession of the receiving party prior to its receipt of such data or information;
- Is independently developed by the receiving party without reference to the confidential information of the disclosing party
- Is rightfully obtained by the receiving party from a third party or is in the public domain.
- Is disclosed with the written consent of the party whose information it is, or
- Is disclosed pursuant to court order or other legal compulsion, after providing prior notice to the disclosing party





## **ARTICLE-VI: AMENDMENTS**

Any amendment add/or addenda to the AGREEMENT shall be in writing and signed by the PARTIES hereto and shall only after such execution be deemed to form part of the

AGREEMENT and have the effect of modifying the AGREEMENT to the extent required by such amendment or addenda.

## **ARTICLE-VII: RESOLUTION OF DISPUTES**

- This agreement shall take effect and be construed in accordance with the Laws of India and be subject to the jurisdiction of mutual concenses.
- The dispute or difference whatsoever arises between PARTIES in relation to or in connection with this AGREEMENT both the parties shall first try to resolve the dispute/difference amicably between themselves, failing which the matter shall be referred to and settled through arbitration. The arbitration proceedings shall be held in accordance with the provision of THE ARBITRATION AND CONCILIATION (AMENDMENT) ACT, 2015. The venue of arbitration shall be Chandigarh and Language of arbitration shall be English.

## **ARTICLE-IX: MISCELLANEOUS**

- The headings and subheadings are inserted for convenience only and shall not affect the construction of this Agreement.
- Both SLIET, LONGOWAL and SABUDH FOUNDATION shall not, during the term of this Agreement directly or indirectly, solicit or offer employment or engagement to any of the personnel of other party without the prior consent in writing of that other party.
- No failure to exercise and no delay in exercising, on the part of a Party, and right, remedy, power or privilege hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right, remedy, power or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power or privilege. The rights, remedies, power and remedies, powers and privileges provided by law.
- After this Agreement has been signed, all preceding understandings/negotiations and correspondence pertaining to it shall become null and void.






