Sanction of Anusandhan National Research Foundation (ANRF) is hereby accorded for the above-mentioned project under **Inclusivity Research Grant(IRG) Program** at a total cost of **Rs. 5723040/-** (Rs. Fifty Seven Lakh Twenty Three Thousand and Forty Only) with break-up of **Rs. 3000000/-** under Capital (Non-recurring) head and **Rs. 2723040/-** under General (Recurring) head for a duration of 36 months. 2. Sanction of the grant is subject to the conditions as detailed in Terms & Conditions, available in the website (www.anrfonline.in).

3. Overhead expenses are meant for the host Institute towards the cost for providing infrastructural facilities and general administrative support etc.

4. Operational flexibility is provided to utilise the funds under the Recurring-I head, subject to the following conditions.

- The expenditure under the travel head is limited to Rs.300000/-.
- International travel for project-related work is permitted within the travel head. However, the expenditure is limited to Rs. 3 Lakh for a three-year project, and proportionately lower for projects of shorter duration.
- The expenditure under the contingency head is limited to Rs.300000/-.
- Contingency funds can be utilized for registration charges for international conferences.

5. As per rule 211 of GFR, the accounts of the project shall be open to inspection by sanctioning authority/audit whenever the institute is called upon to do so.

6. The sanctioned equipment would be procured as per GFR and disposal of the same would be done with prior approval of ANRF.

7. The research personnel sanctioned in the project, if any, is co-terminus with the duration of the project and ANRF will have no liability to meet the fellowship and the salary of supporting staff, if any, beyond the duration of the project.

8. The institute will furnish to the ANRF, separate Utilization certificate (UCs) financial year-wise for Recurring (Grants-in-aid General) & Non-Recurring (Grants for creation of capital assets) and an audited statement of accounts pertaining to the grant immediately after the end of each financial year.


9. The institute will maintain separate audited accounts for the project. A part or whole of the grant must be kept in an interest earning bank account which is to be reported to ANRF. The budget head-wise interest thus earned will have to be returned to the ANRF by way of a Demand Draft/account-payee cheque drawn in favour of the "Science and Engineering Research Fund", payable at New Delhi and sent to the DDO, ANRF along with a copy of UC/SE.

10. The institute must refund any unspent balance to ANRF by way of a Demand Draft/account-payee cheque drawn in favour of the "Science and Engineering Research Fund", payable at New Delhi

11. The project File no. ANRF/IRG/2024/001357/ENS may also be mentioned in all research communications arising from the above project with due acknowledgement of ANRF. The institute should ensure that the technical support/financial assistance provided by ANRF should invariably be highlighted/ acknowledged in their media releases as well as in bold letters in the opening paragraphs of their Annual Report.

12. In addition, the investigator/host institute must acknowledge the support provided to them in all publications, patents and any other output emanating out of the project/program funded by ANRF.

13. The Sanction order for release of funds under non-recurring and recurring will be issued separately depending on the availability of funds. The project becomes operational from the day, the first release of grant is received by the implementing Institute.




